- 3. *Teleconference, Hybrid or In-person meeting on March 8th, 2023. California's State of Emergency related to the Covid 19 pandemic will end on February 28, 2023. The Coordinating Committee can continue to meet virtually if desired following pre-Covid Brown Act requirements Stevenson (10 min) Discussion: Ms. Snyder suggested that the host make the site accessible for the time of the meeting; this is a deviation from Brown Act rules that would require the CC to revise Brown Act status.
 Ms. Snyder: Motion to Amend MOU to allow virtual meetings with only one agency providing the location for public participation. Mr. Silke: second. Approved: unanimous (Lake, Napa, Solano, Yolo)
 Sara Leicht to amend MOU amendment to include modified meeting rules.

 - 5. Dunnigan Groundwater Recharge Project update Ryan Fulton, LWA.

Mr. Fulton provided an update on the Dunnigan area recharge project using the slides provided in the agenda packet. Monitoring wells consist of two ag wells, two abandoned wells, no new wells drilled. Recent rains have led to the application of more water to the fields. Looking for more opportunities to use the ephemeral streams.

6. Lake County IRWM DACI projects update – Scott Harter, LCSD

Mr. Harter provided an update on Lake County Disadvantaged Community implementation projects.











7. Drought Roundtable Discussion – Intra-region drought & planning update

Solano: Mr. Stevenson: Lake Berryessa has gained 140K af in past week, and now has a 3.5 year supply. Not sure about groundwater levels. Solano County has had less impact from the drought.

Lake: Ms. Deligiannis: CA DWR drought resilience plan guidebook out for public review – Lake County will be using it https://water.ca.gov/News/Public-Notices/2022/Dec-22/Public-Comment-Period-Opens-for-Draft-County-Drought-Resilience-Plan-Guidebook. Ms. DePalma-Dow: Rumsey at 1.39, if 70 – 80 more inches, will get to full Rumsey. https://www.cnrfc.noaa.gov/graphicalRVF.php?id=CLKC1 Mr. Fox: groundwater: compared to last month, most wells up between 5 – 10 feet, good news for domestic wells in Big Valley basin. Ms. Gordon: HVLCSD has been awarded funding for drought mitigation projects, mainline improvements, storage, generators for water booster pump stations.

Napa: Flood monitoring, but no floods yet. Bypass project successful at diverting flows away from City. **Yolo:** Ms. Leicht: Indian Valley Reservoir is at ~ 80k af, an increase of ~ 30k af. Groundwater levels, many wells up to about where they were in spring 2022. This spring, continuing to use DWR funding for dry well assistance; dry well reports no longer coming in, but ongoing issue of residents unable to afford well replacement. The dry well response in Yolo is funded through to Small Community Drought relief program: https://water.ca.gov/Water-Basics/Drought/Drought-Funding/Small-Community-Drought-Relief. Ms. Snyder: YC collectively is coordinating a public water awareness event in April.

8. DWR Update - Matti Siltanen, DWR

Mr. Siltanen went through the DWR update PDF with the group, paying special attention to the highlighted opportunities.

9. Presentation: Adaptation Planning Grant Program – Abby Edwards, Governor's Office of Planning and Research

What is the Adaptation Planning Grant Program (APGP)?

- APGP leverages \$25 million to fund local, regional, and tribal communities in integrated climate adaptation planning.
- Round 1 \$6.6 million is available with award amounts ranging between \$150,000-\$650,000

What are the APGP priorities?

- Explicitly and meaningfully prioritize equitable outcomes
- Encourage communities to equitably plan for and respond to multiple climate risks
- Support integrated social and physical infrastructure planning to achieve community resilience
- Build statewide capacity to plan for and implement equitable planning strategies
- Embed equity into the planning process, from project visioning through project evaluation



Who is eligible to apply?

- Local public entities, California Native American Tribes, community-based organizations, and nonprofits
- Partnership
 - Public entity support
 - Community support

How do you apply?

- Complete the Request for Full Application Intent Survey
- APGP staff will provide a direct link to an individual folder to upload Application materials
- Full Applications are due by 5 p.m. on Friday, March 31, 2023 to SharePoint
- Applicants will not be able to access their folder after the submission deadline

Review and Awards

- Applications will be reviewed and evaluated by APGP staff and an interagency review panel.
- Following the initial application review, members of the review panel will conduct interviews with top scoring applicants.
- APGP anticipates making awards on June 1, 2023
